## **St Hilda's needs your help because.....**

We have no source of income from any foundation so the Governors rely on donations from parents to fulfil their legal obligations in maintaining a safe working environment with extra-curricular opportunities for students and to help fund new projects.

### **What we are doing as a school ...**

We recently launched our Friends of St Hilda's group (FOSH) and we are going to work together to raise vital funds to ensure that our students have spaces to relax, read, enjoy extra-curricular activities and increase their fitness. We will let you know about our latest event soon.

## **Gift Aid - How it works.....**

If you pay income tax, the school can recover from the Inland Revenue the tax that you have already paid on the donation you make by Gift Aid. This means if you pay, for example, £10 per month, the school can reclaim a further £2.50.

If you do not pay income tax, any donation, however small, would still be valuable to us.

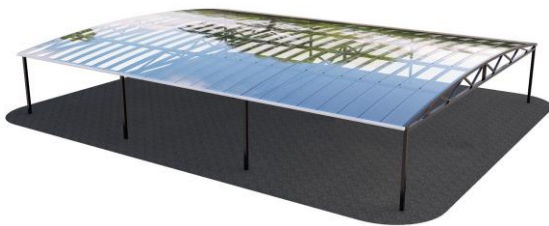
## **Some of the past successes in our old school.....**
