## Dear parent/carer

You will by now have received your letter from Steve Reddy regarding the opening of Liverpool schools on 1<sup>st</sup> June for the children of Key Workers<sup>i</sup> and vulnerable children<sup>ii</sup>. We have risk assessed the school and, in order to open safely, we have had to make some amendments to the building to ensure the safety of staff and students. We opened on 1<sup>st</sup> June for vulnerable students and the children of key workers only. Please note that if your child is in receipt of a shielding letter, they must continue to shield as per instructions in the letter.

Supervised learning in small groups to allow social distancing will take place. Students will not follow a normal timetable and will not be taught in normal lessons with their normal teachers. They will be completing the work set by their subject teachers under our supervision. All children who do attend will need to bring a packed lunch. There will be no opportunities to buy food. Families who qualify for free school meals have been provided with vouchers so food will not be provided in school. The building will only be open during core hours; students will not be allowed in the building before <a href="mailto:9.00am">9.00am</a> and must leave or be collected promptly at <a href="mailto:2.30pm">2.30pm</a>. There will be no school bus provision and we do not recommend the use of public transport at this time. The only entrance will be the main entrance for visitors. If your child becomes unwell in school, you must come to pick them up immediately. Students are expected to wear school uniform and we advise that it is clean every day, please refer to the additional guidance provided.

For the purposes of planning staff ratios and enabling us to create safe social distancing 'bubbles', please notify us of the days your child will attend in advance. Your child will not be able to attend on a day that you have not indicated. Students who attend must attend 9.00 - 2.30. There will be no alternative drop off or pick up times.

If you feel that your family falls into this category **and** are planning to send your child(ren) to school, please respond to the form (link below). It is imperative that we have this information by 12 noon Thursday 2 July to allow us to plan effectively. If you do not respond by this time there will be no provision for your child for the week beginning Monday 6<sup>th</sup> July.

Please note: places are booked on a weekly basis, therefore, if you child has already attended, you will still need to let us know days required by completing the form.
